## **KEY JOB FUNCTIONS/RESPONSIBILITIES**

- Able to affirm to the vision, mission, and guiding values of Wewena Minodoodawin Health & Social Services, and the Chippewas of Rama First Nation by demonstrating commitment to personal growth and wellbeing and the ability to develop healthy relationships that encompass compassion and dignity with sensitivity to issues related to poverty, homelessness, mental illness, addictions, developmental disabilities, complex health issues, ensuring a strengths based, trauma informed approach to care.
- Act as a patient advocate ensuring patients receive the appropriate and accessible primary health care.
- Examine, assess and screen individuals to coordinate and initiate follow up with existing medical and other health care services and appointments and appointments with various health care providers.
- Conduct regular home visits and closely monitor patient health care needs.
- Promote and conduct patient education, prescription drug treatment, appointment retention and lifestyle assessments.
- Act as a healthcare educator to patients and their caregivers.
- Complete assessment and treatment skills to patients as needed.
- Provide guidance to patients related to diabetes prevention and treatment, hypertension, congestive heart failure, chronic obstructive pulmonary disease, fall assessment, injury evaluation, geriatric frailty visits and self neglect assessments and nutrition.
- Develop and deliver a variety of educational sessions to the community.
- Be flexible and creative in program design, implementation and evaluation.
- Participate in ongoing program design and training as needed.
- Participate and assist with wellness clinics, vaccination and testing clinics.
- Collaborate with the Community Health Care Team and liaise with other community and regional resources as needed.
- Complete written and/or verbal reports as required.
- Prepare reports on issues involving services to include direct contact and support, quality improvement and quality assurance.
